Jedd Schola called the meeting to order at 9:00am and led the pledge. Commissioner Strait was on a conference call with state officials and was delayed.

Bob Richardson made a motion to approve the October 6, 2025 meeting minutes as presented; Jedd Schola seconded. 2/0

Invoices were presented.

A proclamation declaring October as Breast Cancer Awareness Month and declaring October 17, 2025 as Mammography Day was presented and signed.

A proclamation declaring October as Domestic Violence Awareness Month was presented and signed.

Barbour County Sheriff's Department had nothing to report.

The Prosecuting Attorney is seeking a Paralegal position and requesting to move his contingency funds to salaries and requesting additional funds of \$20,000. Discussion was held and will be tabled until later in the meeting.

David Strait made a motion to approve the consent to hire of Alexis Ervin to fill a vacancy in the Circuit Clerk's office; Bob Richardson seconded. 3/0

OEM/911 is preparing for cold weather and shelter preps/trainings.

The damaged recorder has been replaced. Dylan requested to change the support vendor from Sound Communications to Carolina Recording Systems who offers 24/7 365 support. On a motion by David Strait; seconded by Jedd Schola, the yearly support contract was approved in the amount of \$15,000, beginning January 1, 2026.

Jody Carpenter reported additional information on rent options with the Tygart Valley Conservation District. TVCD adjusted the rent to match \$12.00/sq. ft. Discussion was held.

Pros and cons were weighed for each location, stating that a priority is youth development. The Extension Service has outgrown the TVCD location and it is limited for youth development programming. Jedd Schola made a motion to approve moving the Barbour County Extension Service to Battlers Knob with a lease agreement of 1,483sq. ft. for \$12.14/sq. ft. including utilities.

Caroline Davis presented information on Northern Appalachian Coal Mining Heritage Association's initiatives. Bob Richardson made a motion to contribute \$500.00, seconded by Jedd Schola. 3/0

On a motion by David Strait, seconded by Jedd Schola, a contribution of \$2,500 was approved to the Corridor H Authority. 3/0

The floor was open for public comment by order of the sign-in sheet.

Commissioner Richardson reported that GoMart has committed to opening a gas station in Belington at the previous Sheetz location and will open in late winter/ early spring.

Commissioner Strait thanked Commissioner Schola for opening the meeting while he was on a conference call representing rural counties with key community, county and state leaders. A common trend is that public safety absorbs a large part of county's budgets. Discussions will be ongoing with a goal to put together legislation that can pass.

The next regular meeting is scheduled for November 3, 2025 beginning at 5:00pm.
