Prosecutor Hoxie did not have an update regarding the Intergovernmental Agreement negotiations with the City of Philippi regarding the sewer extension to Arch Coal facilities.

Shane Whitehair, Region VII Planning and Development Council discussed their involvement the City of Philippi's Sewer line extension project and EDA grant funding. Region VII's role is to ensure the City of Philippi remains in compliance of the grant terms. He expressed concerns of nearing project deadlines and rising costs of materials.

Approval on the Intergovernmental Agreement was tabled until further communication.

On a motion by Susie Cvechko and seconded by David Strait, the yearly IT Support Contract with Global Science Technology (GST) was approved at \$1,702.00 per month, an increase of \$110.00 with added Cybersecurity V-Scan service, for the period of 1/1/2022 to 12/31/2022.

On a motion by Jamie Carpenter, seconded by David Strait a resolution was approved to submit an application to the Department of Agriculture for grant funds to offer vouchers toward spay and neuter services. If awarded, the County Commission program should begin around May.

Shana Frey discussed the Transitional Training Program through Region VI Workforce Development Council. If approved, the County Commission can employ an individual under this program and get reimbursed for their salary. Additional programs are available and will be reviewed with the program director. On a motion by Susie Cvechko, seconded by Jamie Carpenter, the County Commission will participate in the program and sign the required documents to get the program started. 3/0

Prosecutor Hoxie submitted a request for a budget revision in the amount of \$11,050.00 for FY 2021-2022 and consent to hire a Kelsey Grose as an Assistant Prosecutor. He also explained that his VOCA position became vacant and Jennifer Baylor-Nine is transferring to the VOCA position. On a motion by David Strait, seconded by Jamie Carpenter, the budget revision and consent to hire was approved. 3/0

Discussion was held regarding the Barbour County Solid Waste Authority and Recycling Center. Information is still being gathered.

Dylan Harper, 911 Director provided a report on the 911 Center.
